- People must call Yellow Cab of Terre Haute and mention the program to get a free ride home.
- Cab rides are provided from a bar or restaurant to an individual's residence – not to other drinking locations.
- Due to the high number of ride requests, rides cannot be guaranteed for everyone who calls; however, every attempt will be made to accommodate all requests. Drivers have the right to use their discretion when accepting fares.
- Please be sure to call at least a half hour before you would like to be picked up. Due to the number of cab drivers, you could be waiting a short while.

Launched on New Year's Eve 2008, the Safe and Sober Free Cab Ride Home program provides a safe transportation alternative during many of the traditionally high alcohol consumption holidays. Cab rides are made available on New Year's Eve, The Professional Football Championship Game, St. Patrick's Day, Halloween, and Thanksgiving Eve to area residents who otherwise might attempt to drive home after drinking.
