But in all the fun, it can be easy for parents to overlook certain risks that Halloween costumes can pose. Here are important safety tips to remember when choosing the best Halloween costume.

Look for fire-resistant costumes.

Candles inside jack-o'-lanterns and other open flames are everywhere on Halloween night, so make sure your child's costume isn't a fire hazard. Most store-bought costumes are made from fire-resistant materials, but you should still check the labels on all costumes, wigs, and accessories. The same goes when you're buying fabric for homemade costumes. And remember, fire-resistant is not the same as fireproof. While fire-resistant material takes longer to burn and can be put out quickly, it can still catch fire and cause serious injuries. Remind your child to use caution around open flames and avoid costumes with flimsy, hanging components, like flowing sleeves, long skirts, and capes.

Test makeup first.

Halloween is a great time to have fun with face paint, and makeup is a good alternative to masks, which can obscure a child's vision. However, a lot of costume makeup isn't approved by the Food and Drug Administration. Before letting your child cover his face in makeup from the Halloween store, test their skin for allergic reactions by putting just a little bit on the back of their hand first.

Practice prop safety.

What's a Jedi Knight without her lightsaber or a wizard without his magic wand? The right accessories can really bring a costume together, but it's important that props especially weapon props, like swords, knives, or guns - are not mistaken for the real thing. Choose props that are obviously fake, with round edges made from soft, flexible material. And if your child wants to wear her Halloween costume to school or some other event, check the rules on props beforehand to avoid any trouble.

Most Haunted Houses in the USA

'Tis the season to sit around a campfire, roast marshmallows, and tell creepy ghost stories to all your friends. Whether you believe in that sort of thing or not, here is a list of real haunted houses around the country and the stories behind them.

1. McRaven House in Vicksburg, Mississippi



This pre-Civil War home has been featured on several television shows about ghosts and will also schedule live ghost tours. It is said the house is haunted by Mary Elizabeth Howard, who died in 1836 shortly after giving birth, and John Bobb, who was murdered outside by Union troops. 2. Monroe House in Hartford City, Indiana



This house has been featured on the TLC program, Paranormal Lockdown and had experienced ghost hunters scared out of their wits during investigations. Neighbors report shadowy figures in the windows, lights turning off and on, poltergeist activity, and human remains have even been found buried in the basement. Read all about the house here.

3. Waverly Hills Sanatorium in Louisville, Kentucky



Although this isn't technically a "house", many people lived here throughout time. Considered one of the most haunted places in the world, this former tuberculosis clinic saw so many deaths in the early 1900's that a special body chute was eventually installed to send bodies directly to the onsite crematory. 4. Molly Brown House Museum in Denver, Colorado



Yes, that would be the iconic Titanic survivor, "Unsinkable Molly Brown." Her former home is now open for history and ghost tours after a recent but remarkable complete restoration to its original glory. The ghosts of the house's former owners, Molly and J.J. Brown, as well as Molly's mother, are said to roam the property. Phantom piano music, chairs rocking on their own, and the smell of smoke from a non-existent pipe are just a few of the things people have experienced. Read more about the Molly Brown House here.

5. Farnsworth House Inn in Gettysburg, Pennsylvania



This house was built in 1810 and named in honor of Brigadier General Elon John Farnsworth, who led an ill-fated charge after the failure of Pickett's charge. The house sheltered Confederate sharpshooters during the three-day conflict and has more than 100 bullet holes in the walls. Following the battle, the house served as a hospital. Today, you can experience Paranormal nights, tours, and other events that are regularly held in the house. Guests have reported being woken up in the middle of the night by mysterious spirits. In the state of Indiana, we have some local creepy ghost legends that will make your skin crawl. Here are some especially creepy stories that might just keep you up at night. Enjoy!

- 1. 100 Step Cemetery. This story differs, depending on who you ask or where you read it. But basically, the legend goes like this: if you walk up and down a certain section of steps in a cemetery, you must count to 100 while going in each direction. If you don't, you are going to die soon. Some people even believe when you get to the top of the stairs, the original caretaker of the grounds will appear and show you your death. Some people also believe that if you try to go up the hill without using the stairs, a phantom hand will push you down the hill! Spooky!
- 2. The Haunted Bridge (Avon, Indiana). Legend has it that while you go fishing near this bridge, you can hear screams and knocking coming from inside its support pillars. (Supposedly, while the bridge was being built, a worker perished there.) There's another legend that claims a woman was walking along the bridge to her doctor's house with her sick baby one night, when her foot got stuck in the track. She managed to get her foot out but had no choice but to jump off the bridge into the water. The women is believed to have survived while her baby did not. Some people believe you can hear her screaming for her baby at the bottom of the bridge at night.
- 3. Saint Mary of the Woods College. As the story goes, one of the sisters at the school had a talent for painting portraits and spent many an afternoon in Foley Hall capturing every nuance of her current subject at hand, always saving the face for last. Lacking a subject for a time, the nun decided to do a self-portrait, and spent countless hours working out every detail of her painting until it came time, finally, to recreate her own face. Unfortunately, she fell ill that very day and was rushed to the infirmary. Although the doctors could find nothing wrong with her, she mysteriously died, leaving the portrait unfinished. Shortly after the nun's passing, paranormal sightings began to occur, with students and staff reporting a shadowy nun roaming Foley Hall and its courtyard. Recipe of the Month Stephanie's Chocolate Cookie Butter Cookies



Ingredients:

- 1 cup butter (no substitutes)
- 1/2 teaspoon vanilla extract • 2 cups all-purpose flour
- 1 cup confectioners' sugar
- 1 cup (6 ounces) miniature semisweet chocolate chips

Directions:

- 1. Melt butter in microwave; stir in vanilla. Cool completely.
- 2. In a large bowl, combine flour and sugar; stir in butter mixture and chocolate chips (mixture will be crumbly). Shape into 1-inch balls.
- 3. Place 2 inches apart on ungreased baking sheets; flatten slightly.

Bake at 375 F for 12 minutes or until edges begin to brown. Cool on wire racks.

Makes about 4 dozen cookies.
